#### Who should use this form?

Anyone who is in nursing home care through the Fair Deal scheme and is renting their principal private residence can complete this form. This principal residence must be registered with the Residential Tenancies Board (RTB).

Rental income from a principal residence which is not registered with the Residential Tenancies Board may still be eligible see www.rtb.ie for more information.

The Nursing Homes Support Scheme, provides for the principal private residence of that person to be assessed at a lower rate than other incomes of that person. The rate of assessment applicable to principal private residence rental income is 0% instead of 80% which is applied to all other incomes.

#### Who can make an application?

The applicant.

If the applicant is unable to complete the application form on their own behalf, a Specified Person, Decision Making Representative or Care Representative may complete the application form. Contact details can be provided on page 3.

The following requirements must be met:

- The person is receiving care services supported by the Fair Deal Scheme.
- Any payments made in respect of rent are made to the person or their partner.
- The property is the principal residence of the person receiving care services.
- The tenancy of the property is registered with the Residential Tenancies Board.
